INTRODUCTION

Personal Interest and Acknowledgements

My interest in Dr. John Howe Hoge is based upon three things: (1) he delivered my grandmother, Cynthia Ellen Wohlford, when she was born to Gordon and Matilda Byrnes Wohlford September 27, 1882; (2) my grandfather, Joseph Hoge Hetherington, lived and worked for him when he was a young man; and (3) I transcribed Dr. Hoge's journal (from 1877 until his death in 1895). Dr. Hoge was an interesting individual. Since he was engaged in so many areas of life: ministry, medicine, farming, etc., I have organized this book with that in mind.

I want to thank my wife, Elizabeth Branyon Hetherington, for helping me do research, format and edit this book.

Ancestors Who Migrated to America

John Howe Hoge descended from William Hoge (1669, Scotland-8 AUG 1749, Frederick Co., VA) and Barbara Lambert Hume (1670, Scotland-19 FEB 1745, Frederick Co., VA). The Hoge and Hume families were two of several families on the ship <u>Caledonia</u> traveling from Glasgow, Scotland, to New York City, New York, during 1682. Along the way, William and Barbara developed a friendship. Also, along the way, Barbara's parents became ill and died leaving her alone. Upon arrival in New York, an uncle, Dr. Johnson of New York, took Barbara to live in his household. William Hoge settled in Perth Amboy, a community in New Jersey and near New York City. William and Barbara developed a romantic relationship. They were married 1685, New Jersey. They move to Delaware, then Pennsylvania and eventually settled in Frederick County, Virginia 1735. 

Daniel Howe Hoge received several Virginia Land Grants. One example is as follows:

David Campbell, esquire, Governor of the Commonwealth of Virginia: To all to whom these presents shall come, Greeting: Know ye, that in conformity with a survey made in the 13th day of March 1837 by virtue of Land Office Treasury Warrant No. 2657, there is granted by the said Commonwealth, unto Daniel Hoge a certain tract or parcel of land containing sixteen acres situate in Giles County on the waters of Walkers Creek bounded as follows: Beginning at a large chestnut oak on the south side of the Brushy Mountain and on a line of said Hoge's land and also on a line of a large survey, and with lines of the former S89E 52 poles to two white oaks, corner to the same on a flat ridge; N87E 190 poles to a white oak and black oak on a flat ridge; N4W 12 poles to a hickory on the big survey line and with it leaving the lines of his land; S80W 232 poles to the beginning, with its appurtenances to have and to hold the said tract or parcel of land, with its appurtenances, to the said Daniel Hoge and his heirs forever. In witness whereof, the said David Campbell, esquire, Governor of the Commonwealth of Virginia, hath hereunto set his hand, and caused the lesser seal of the said Commonwealth to be affixed, at Richmond, on the 30th day of November in the year of our Lord one thousand eight hundred and thirty 8 and of the Commonwealth the 63rd. Daniel and Nancy moved from Wythe County to Scott County, Virginia 1852.

Nancy died February 12, 1853. Daniel married Delilia Hyatt [Hiett] (1802-?) May 1, 1856, Russell County, Virginia. Daniel died March 28, 1857, Coeburn, Wise County, Virginia. Daniel and Nancy were buried in the Hoge Family Cemetery, Coeburn, Wise County, Virginia.





CHAPTER THREE

LAND OWNER

Over the years, John Howe Hoge owned many properties and acres in several counties in Virginia. Some properties were acquired through Virginia land grants and others by purchase. He seemed to be very successful dealing in land. There never was a time during his adult life when he did not own several properties.

Wythe County, Virginia

Only one land grant has been discovered from Wythe County as follows:

David Campbell, Esquire, Governor of the Commonwealth of Virginia: To all to whom these presents shall come ... Greeting: Know Ye, That in conformity with a survey made the 11th day of August 1837, by virtue of an order of the County Court of Wythe County, there is granted by the said Commonwealth, unto John H. Hoge, a certain Tract of land Viz: one tract of 187 acres, one of 49 acres, one of 78 acres and one of 115 acres including a certain Tract or Parcel of land containing four hundred and twenty acres and situatate in Wythe County bounded as follows: Beginning at three white oaks, one of them double by a branch, a corner to the first named tract of 187 acres and corner to the line of division between said Hoge and David Graham; thence with said line N31W 45 poles crossing said branch to a white oak sapling blazed, S57W 90 poles to three white oak sapling, N23W 122 poles to a stake near a hickory and three white oak sapling on the top of a ridge, S37W 98 poles to three red oaks on a line of said survey of 49 acres & with line of the same S73W 82 poles to a white oak sapling & dead black oak by a gully, S40W 22 poles to a black oak, S50W 76 poles to a black oak corner to George Walton's land and with said Walton's lines S56E poles to a Spanish oak in said line, S74E 205 poles to two black oaks, \$40E 52 poles to a white oak and hickory sapling & leaving Walton's line S45E 141 poles to two hickories on a high ridge, N67E 34 poles to a black oak, N52E 43 poles to a hickory corner to the land deeded by John Bethel to said Hoge & with lines thereof N56E 88 poles to two black oaks on a ridge ... (Unreadable)... N13W 122 poles to two white oak saplings & chestnut, S68W 50 poles to a black oak & N82W 40 poles to the beginning with its appurtenances. To have and to hold the said Tract or Pracel of Land, with its appurtenances, to said John H. Hoge and his heirs forever. In witness whereof, the said David Campbell, Esquire, Governor of the Commonwealth of Virginia, hath hereto set his hand and caused the Lesser Seal of the said Commonwealth to be affixed, at Richmond, on the 15th day of October in the year of our Lord one thousand eight hundred and thirty nine and of the Commonwealth the sixty fourth. David Campbell

From the above land grant it can be determined that John H. Hoge owned a tract of land in Wythe County deeded to him by John Bethel.

Pulaski County, Virginia


By the age of 24, he owned nine parcels of land containing totally approximately 1,332 acres in Pulaski County, Virginia. Most of these parcels were in the Back Creek area approximately 10 miles north of the court house. Over the years the number of parcels and acreage varied up and down a little; however, even when he was no longer a resident of Pulaski County, he maintained ownership of most of these.

One example is a land grant as follows:

Henry A. Wise, Esquire, Governor of the Commonwealth of Virginia: To all to whom these presents shall come ... Greeting: Know Ye, That in conformity with a survey made the twenty fourth day of June One Thousand eight hundred and fifty eight, by virtue of Land Treasury Warrant No. 23837, there is granted by the said Commonwealth, unto John H. Hoge, a certain Tract or Parcel of Land, containing one acre, three rods and twenty one poles lying in Pulaski County, and bounded as follows, viz: Beginning at 4 white oaks above the Thorn Spring Campground, corner of John Jordan's Vineyard tract of land, and also a corner to a tract of land formally belonging to Wm. Hoge, and with a line of said tract North West 124 poles to a stake, corner to said Jordan's Vineyard tract; Thence with line of the same N 57 degrees E to a stake where said deed calls for two white oaks; Thence S 3 ½ E 12 poles to the beginning, with it appurtenances. To have and to hold the said Tract or Pracel of Land, with its appurtenances, to said John H. Hoge and his heirs forever. In witness whereof, the said Henry A. Wise, Esquire, Governor of the Commonwealth of Virginia, hath hereto set his hand and caused the Lesser Seal of the said Commonwealth to be affixed, at Richmond, on the first day of September in the year of our Lord one thousand eight hundred and fifty nine and of the Commonwealth the eighty fourth. Henry a. Wise

Giles County, Virginia

John Hoge owned three large parcels of property (17 acres, 175 acres and 90 acres) in Giles County and two lots in Mechanicsburg, Giles County. The parcels were purchased by him during the 1830's – 1850's. He maintained ownership of these parcels for many years. One example is the 175 acres he owned, which was adjacent to Mechanicsburg, as presented below.



The parcel of land to the left is 175 acres belonging to John Hoge from about 1851 to 1874. It is located at the west end of Mechanicsburg. He purchased this parcel, located in Giles County at that time, from John Eaton for \$1,500.00 in 1851. He sold it, located at that time in Bland County, to William P. Mustard in 1874, for \$2.500.00.

To have and to hold the said Tract or Parcel of Land with its appurtenances, to the said John H. Hoge and his heirs forever. In witness whereof, the said Henry A. 


After John Hoge moved from Wise County to Bland County in the early 60's, he lived on his property located on the west end of Mechanicsburg. From 1863 through 1893, John Hoge purchased over 20 parcels containing a total of more than 3,261 acres. He kept some parcels for many years and some for only a few. The point is that he bought and sold many acres of land in Bland County. He also owned houses and lots in the towns of Seddon and Mechanicsburg.

January 16, 1872, he purchased 350 acres from James Hoge and others for \$150.00. This property on Walkers Creek Road was located a little west of the intersection of Route 308 and Walkers Creek Road. He lived on this property until his death in 1895. Upon his death, part of the property was willed to Wiley and Mollie Compton and another part to James and Sue Robinett.

Witnesseth that the parties of the first part for the love they have for Christ and the M.E. Church South and for the further sum of One dollar in hand paid, the receipt thereof is hereby acknowledged doth hereby give, grant and sell to the said Trustees and their successors in office appointed by the Quarterly Conference of said church a certain parcel of land upon which a church has been erected called Hoge's Chapel and bounded as follows: Beginning at a stake on the Turnpike road a north course from the church, and running thence with said road S25W 18 poles to a stake on the south bank of the spring branch so as to include the spring near a low bush, thence S65E 18 poles to a sourwood, thence N25E 18 poles to some low bushes and a thornbush in an old ___ in a pile or ledge of rocks, thence N65W 18 poles to the beginning, containing two acres. The said Rhoda Helvey and Sarah B. This deed made and entered into this 6th day of April in the year of Christ one thousand eight hundred and ninety one (1891) between Daniel O. McNiel and Sarah Ellen his wife of the first part and John H. Hoge and James W. Robinett of the second part all of the County of Bland State of Virginia, witnesseth: that the party of the first part for and in consideration of the sum of one thousand dollars in hand paid the receipt whereof is hereby acknowledged, hath sold by these presents doth convey unto the party of the second part a certain boundary of land containing some 2 acres upon which a saw and grist mill has been erected where once stood a mill known as the Elias Harman mill, situate and being in the County of Bland State of Virginia and bounded as follows to wit: Beginning on a spruce pine on the south bank of Walkers Creek not far from J. Wash. Kitts' house some 200 yards below the mill dam; thence a little west of north down the bluff about 3 poles to the middle of the creek to a stake; thence down the creek 3 1/3 poles to a stake in the middle of the creek; thence a little west of north 18 ½ poles passing on the east side of the stable to a stake by a gate post on the south bank of a

Hoge, Trustees for the Presbyterian Church in the United States within the Abingdon Presbytery; and of the County and State aforesaid parties of the second part: Wintesseth, That the said parties of the first part for and in consideration of their love and affection for said church and their desire for its well being and prosperity; and for further consideration of an dollar to the paid in hand paid, the receipt whereof is hereby acknowledged, do grant and convey unto the said Ballard P. Brown, Abram F. Harman and William H. Hoge, Trustees as aforesaid, for the Presbyterian Church in the US in their bounds of Abingdon Presbytery all that certain tract of land lying in Bland County, Virginia, on the waters of Helvey's Mill Creek, a branch of Walkers Big Creek, known as the "Point Pleasant Church lot,: and containing one square acre by the same more or less and bounded as follows to wit: Beginning at a stone near the south east corner of the church and running thence S45W 210 feet to a stone, thence N45W 210 feet to a stone, thence N45E 210 to a stone near the public school lot, thence S45E 210 feet to the beginning to have and to hold the said tract of land unto them the said parties of the second part as herein before maintained or their successors as Trustees for the Presbyterian Church in the US for the sole user and behalf of the said Presbyterian Church in the US for church and cemetery purposes forever, but with the further provision that whenever said church ceases to use said property for church and cemetery purposes or shall convey it of cause it to be conveyed to another person, for purpose other than the actual use of the Presbyterian Church, then said land shall revert to the originia owners with all the appurtenances thereto belonging and said parties of the first part do hereby grant warrant generally, the property herein conveyed with all appurtenances therein belonging. William E. Hoge to Public School 14 FEB 1882, Bland Deed Book 4, page 472

This deed made this 14th day of February 1882 between Wm E. Hoge of the first part and Wm B. Ashworth and A.F. Miller, public school trustees all of the County of Bland & State of Virginia of the second part. Witnesseth that for the purpose of having a public school house erected and for the further consideration of the said trustees releasing to the said party of the first part all their right title & claim to the lot of land know as the Point Pleasant Academy lot, the said Wm E. Hoge doth grant, bargain & sell to the said parties of the second part as trustees & their successors in office a lot of land north west of said Academy lot bounded as follows to wit: Beginning in the middle of the road running up Helvey's Mill Creek above a ledge of rocks, thence crossing the road above the spring passing a locust tree on the bank to a locust tree, a corner of the Pt. Pleasant Academy lot, thence N-West parallel with the creek a sufficient distance that a line parallel with the first line to the road & down the same will include one acre with the privilege of using water from the spring. It is understood and agreed that should said property cease to be required for public school purposes, the title to the same shall revert to the owner of the continuous land and the said Wm E. Hoge covenants that he will warrant generally the property hereby conveyed. Witness the following signatures and seals.

CHAPTER FOUR

OCCUPATIONS

John Hoge was a man of many interests and occupations. He was interested in local and national politics, community development, medicine, law, ministry, farming, etc. One contemporary writing about his work as a physician wrote that he could have been a genius in medicine if he had not been involved in so many other things.

PHYSICIAN

The first document this writer has discovered identifying John Howe Hoge as a physician is in the 1850 Giles County, Virginia Census. At the time, he was 34 years old. He may have already served as a physician for several years; however, no record has been found indicating that. Also, no record has been found concerning any medical college he may have attended. Although there were some medical schools, the apprenticeship system was the main form of medical training in the early 1800's in the United States. Possibly, John Hoge served as an apprentice to a physician as his preparation for becoming a physician. In regards to being licensed, the first mention of such was in 1885, when he paid Bland County \$10.00 for a license to practice medicine in the county.

During his medical career, he delivered a least 728 children. Almost all of his contact with patients was through home visits. Between 1877 and 1889, he reported about 300 patient visits identified as "sick" visits. These did not include visits to deliver children and pull teeth. Some of the other services he provided were "tapping" fluid, setting broken bones, etc. Again, over 90% of the service he provided related to sickness. It is interesting that on a few occasions he functioned as a veterinarian attending to livestock.

There is one interesting story of Dr. Hoge performing a cesarean on a pregnant woman with severe complications. Two other physicians present had given up on attending the woman. Dr. Hoge performed the cesarean resulting in both the woman and child surviving.

FARMER

In the 1860 Wise County Agriculture Census, John Hoge owed a farm including 3,800 acres valued at \$22,300. His livestock included horses, milk cows, working oxen, cattle, sheep and swine. He raised wheat, corn, beans, potatoes, hay and sugar cane. In the 1870 Bland County Agriculture Census, John Hoge owned two farms: one 400 acres valued at \$500.00 and another 400 acres valued at \$3,500. Only the second farm was a working farm with livestock and other products. His livestock included horses, milk cows, working oxen, cattle, sheep and swine. He raised wheat, rye corn and oats.

It is interesting that in the 1860 Wise County Census, he is listed as having eight free blacks living in his household. It is difficult to determine if he owned enslaved people while living in Bland prior to the end of the Civil War or, if so, how many.

ATTORNEY

There are few records related to John Hoge and the practice of law. He was authorized to practice law in Bland County October 16, 1862. Though a law license was not required, he did take the oath to serve as Deputy Clerk of Bland County December 6, 1869. No records have been found indicating that he served as someone's attorney in a court case; however, numerous times he took depositions for the court. Also, he helped with the probate of several wills and the settlement of estates.

MILL OWNER/OPERATOR


D.O. McNiel sold a saw and grist mill (2 acres) to John Hoge and James Robinett April 6, 1891, lying upon Walkers Creek for \$1,000.00. At one time this mill was known as the Elias Harman Mill. This mill was located near the J. Washington Kitts house and property.

NEWSPAPER EDITOR

John Hoge was the editor of and a contributor to the South-West newspaper in Bland County from 1880 though 1882.

MINISTER

From his own writings near the end of his life, this writer believes that his most important interest was being a faithful follower of Jesus Christ in his personal life and as a minister in the Methodist Church. For example, he wrote, "I have tried to live a Christian here, I want to die rejoicing. ... I am sorry I was not more zealous" On many occasions, he wrote about his conversion September 7, 1834, at the Wabash Campground. He was 19 years old at the time and this experience was the defining moment in his life. He was very appreciative of his parents for his spiritual development as well as Rev. David Byrnes. He wrote, "Next to my parents, I owe my religious training to Mr. Byrnes" (David Byrnes).



The site is located near the junction of Wabash Creek and Walkers Creek between Dublin and Pearisburg, Giles County, Virginia. John Hoge mentioned that he attended meetings at the Wabash Campground Friday, July 22, 1879; Saturday, May 23, 1880; Friday, August 20, 1880; Friday, August 21, 1885 and Thursday, August 21-23, 1889. Certainly, the Wabash Campground was important to spiritual life of John Hoge, as well as many others.

One of the beginning points of his career as a Methodist minister was when he was licensed to preach by the Methodist Episcopal Church June 23, 1838. He was 23 years old at the time. This important event in his life took place at Nisewanders Meeting House with Presiding Elder David Fleming presiding. Nisewanders Meeting House was a meeting place for Methodist near Mechanicsburg, Giles County (at the time). Rev. David Fleming was part of the Holston Conference. He served the Methodist Church for 45 years.

John Hoge's next step in his career as a Methodist minister was his ordination as a deacon October 1843. John was 26 years old at the time. This happened during the annual conference of the Holston Conference at Abingdon, Virginia with Bishop Thomas Asbury Morris presiding. Also, John Hoge was authorized to perform marriages by the Giles County Court in 1843.



In 1844, the Methodist Episcopal Church split over the issue of slavery. Bishop Morris, a Virginian, chose to identify with the Methodist Episcopal Church North rather than the Methodist Episcopal Church South. John Hoge identified with the Methodist Episcopal Church South. In the 1850 Giles County, Virginia Slave Schedule, John Hoge is listed as owning two enslaved persons: one female 34 years old and one female 3 years old. In the 1860 Wise County, Virginia Slave Schedule, John Hoge is listed as owning seventeen enslaved persons.

John Hoge's next step in his career as a Methodist minister was his ordination as an elder in the Methodist Episcopal Church South June 29, 1869, at Giles County, Virginia by Bishop David Seth Dogett presiding.



David Seth Dogett


David Seth Dogett was a bishop of the Methodist Episcopal Church South. A graduate of the University of Virginia, he was appointed a bishop in 1866. Also, he was a professor at Randolph Macon College.

John Hoge was active in ministry his entire adult life, even with his work as a physician, attorney, etc. This is documented in his journal from 1877-1895. From January 1877, until the establishment of Hoges Chapel August 31, 1879, he conducted Sunday services often at Point Pleasant, Bland County, Virginia. In addition to this, he conducted meetings in various places in Bland County: Seddon, Bogle's School House, Salem Church, Doakes Chapel, Pine Grove Church, Mechanicsburg, Neels Church, Burks Church, Shiloh Church and Newberrys Chapel. Also, he conducted meetings in Wise, Pulaski, Giles and Mercer Counties. He participated in conferences at Wabash Campground and Thorn Spring Campground. He attended most quarterly meetings and annual conferences of the Methodist Church South.

Point Pleasant Academy was used as a school, as well as, a place of worship by the Presbyterians (first Sunday of month), Primitive Baptists (second Sunday of month) and Methodist Episcopal Church South (third Sunday of month). The land for Point Pleasant Academy was conveyed by Franklin G. and Nancy Helvey.


In 1879, the Methodist moved to Hoge's Chapel. In 1882, the school district released the Point Pleasant Academy lot to William E. Hoge. At the same time, William E. Hoge conveyed to the school district a lot northeast of the academy lot. In 1892, the Point Pleasant Academy lot was conveyed to the Presbyterian Church for a church house and cemetery.

One of his joys was the establishment of Hoges Chapel, which was near Point Pleasant. He provided the financial support for the building. June 20, 1878, he and others laid the cornerstone for the building. The completed building was dedicated August 31, 1879, by David Sullins. John Hoge wrote in his journal, "Hoges Chapel dedicated by D. Sullins, largest crowd ever collected in this neighborhood, from 1,000 to 1,500."




David Sullins

Rev. David Sullins, D. D., a graduate of Emory and Henry College (1850), was a member of the Holston Conference of Methodists. He served as president of colleges (Centenary Female College, Odd Fellows Female College, Wytheville Female College and Sullins College). During the Civil War he was a chaplain for the 19th Tennessee Infantry and Breckinridge's Division.

John Hoge was very active in his faith and ministry throughout his life. In his journal, he mentioned most of his preaching experiences and attendance at denominational events. Almost every Sunday, he was either leading the service at Hoge's Chapel or some other church.

Some of the places of worship he mentioned are as follows: Point Pleasant, Mount Zion Church, Pleasant Grove Church, Newberry's Chapel, Seddon Church, Hoge's Chapel, Doake's Chapel, Pine Grove Church, etc.

Some journal entries that relate to his faith are as follows:


Summary 1889 "My faith is strong, my hope in lively exercise. My prayer is 'Lord thy will be done'"

Summary 1891 "I bless God. There is a better world than this."

Summary 1893 "How lonely I feel and how sad I would feel were it not for the hope of the glorious resurrection"

Friday, September 7, 1894 "60 years today since I was converted at Wabash Campground"


Summary 1894 "Another year nearer my heavenly home ... have made many mistakes in my lifetime and I feel I have been a great sinner, but Christ is a great Savior"



CHAPTER FIVE

CONCLUSION

Tuesday, April 25, 1895, it is noted in his journal that John Hoge "got sick." This sickness would lead to his death. From May 1, and beyond his death, journal entries were made by his relatives. In his last days, he was attended by Dr. James Ephraim Tarter and Dr. Sherrill. His health continued to decline and Saturday, May 25, the journal notes, "a great many friends came in" to visit with him one last time. The journal notes Wednesday, May 29, "Uncle John H. Hoge died 3 o'clock and 34 minutes pm." His funeral was conducted the next day at Point Pleasant, Thursday, May 30, by Rev. James Alexander Hamilton Shuler. Friday, May 31, his body was taken to Dublin, Pulaski County for a funeral and burial. That funeral was conducted by Rev. Shuler with the Masons participating. Saturday, June 23, the family sold some of John Hoge's livestock (one gray mare \$50.00, one yearling colt [\$21.50], two-year old colt [\$27.00, one cow [\$12.00] and 11 sheep [\$21.12]. Other livestock were sold in the following days. October 1, 1895 the journal notes, "moument erected to Uncle John's grave, cost \$80.00." Wednesday, Christmas Day, December 25, 1895, the journal notes, "paid J.W. Robinett executor of J.H. Hoge \$103 dollars in full account."



WILL OF JOHN HOWE HOGE

In the name of God, Amen. I, John H. Hoge, of Bland County, Virginia, being in feeble health, but of sound mind and disposing memory, in view of the uncertainty of life, do make this my last will and testament.

- 1st, I will my body to the ground from which it came and my soul to God, who gave it, in hopes and with bright prospect of a blessed immortality.
- 2nd, I will and direct that all my just debts be paid including any burial expenses including tombstone and casket.
- 3rd, I will and bequest to my wife, Sarah, all the land of my home place where I now live, north of a line, namely Beginning at a stake by a branch on (D.H. Hoge's and my line one pole northeast of a large elm tree on the west side of said branch, marked as a pointer, thence S31 ½ W 98 poles to a small apple tree, thence N541 ½W 39 poles and 10 links to a small dogwood and small red oak, thence S20 ¾W 85 poles and 15 links to a small chestnut on or near Joseph Waggoner's line, all the land lying north of this line I will to my wife during her natural life, also all the farming tools and implements, also the household and kitchen furniture, also 1 horse, 2 cows, 5 sheep of her own choosing, to have and hold during her natural life, the balance of my, livestock to be sold.
- 4th, I will and bequest to Wylie Compton and Mollie, his wife, all the land bequest to my wife, Sarah, together with the farming ____ tools, also all the livestock, horses, cattle and sheep, which she may own at her death, but she can dispose of any property she may choose or household furniture. And it is my request and will that said Wylie Compton and wife live with my wife, Sarah and have full control of the place as long as they support her (Sarah) in a way that suits her. I will the foregoing to said Compton and wife and their heirs forever.
- 5th, I will and bequest to J.W. Robinett and Sue, his wife, all the lands lying south of the line made in the bequest to my wife, Sarah, and W.J. Compton and Mollie, his wife, which now belongs to me south of said line to the creek or may belong to me at my death, to them and their heirs forever.
- 6th, I will that any Executors hereafter named shall sell all lands outside of my home place at such time and on such terms as they may think best, and all the money ensuing from such sale together with the money I may have on hand and all the money that can be called on bonds or otherwise shall be equally divided between my nephew and niece with the exception of Rev. D.H. Carr, who had received his portion and Sue, J.W. Robinett and Mollie L. Compton. Any executors of this my last will and testament, are to have reasonable time to settle up my estate. They are to receive no pay for settle up any estate as they have such enough in this will. In witness thereof, I have set my hand and affixed my seal this 17th February 1894.

Virginia in Bland County Court June term 1895

The last will and testament of Dr. J.H. Hoge, dec. was this day produced in court and being fully processed by the testimony on oath of W.B. Ashworth and M.S. Bruce to be wholly in the hand writing of the testator himself was ordered to be recorded, And on motion of James W. Robinett, one of the Executors named in said will he has a leave to qualify as such, W.J. Compton, the other Executor therein named appearing in Court declining to qualify.

Therefore,, the said James W. Robinett together with W.J. Compton, W.B. Ashworth, M.S. Bruce and W.H. Hoge, his sureties entered into and acknowledged a bond in the penalty of \$15,000.00 considered according to law, and certificate is hereby granted, said Executors for obtaining Probate of said will in due form of law, And on the further motion of said Executor, B.F. Petree, C.P. Muncy and Jacob A. Waggoner are hereby appointed,. Who after being duly sworn for the purpose will proceed to appraise the personal estate of said Hoge, dec. and make report to Court as prescribed by law.
